### Reminders For 2020

- State Fair accepting ONLINE only entries except for agility. Deadline is June 20.

### Possession Date is June 1, 2020

**Dog must be in the care and possession of the member by June 1, 2020.**

For Obedience, Performance, or Showmanship projects, no one other than the junior fair exhibitor is permitted to show the project dog at any type of dog show, including agility, rally, field trials, as well as fun shows, on or after June 1, 2020.

### Required to complete Project/Show at Fair

1. **Prior to participating in 4-H dog activities with a dog, a Permission to Participate form** must be signed by the 4-H member and a parent/guardian. This document is to be signed each year a youth enrolls in a 4-H dog project and is due in the Extension office **BEFORE** June 1.
2. **Certificate of Vaccination form must be completed and on file at the Extension Office by June 1<sup>st</sup>.** Rabies and DHLPP vaccinations must be current through the dog demonstration date at the fair. Bordetella is recommended but not required. If vaccinations are self-administered, the Lot number and expiration must be documented. A veterinarian must still be listed on the form to ensure you have established a Vet-Client-Patient Relationship.
3. Dogs must have a **current Ashland County dog license.**
4. **Members MUST attend at least 2 county 4-H dog practices to be eligible for the county judging.** You may meet this requirement by attending any of the above practices with Laurie Aulger & Paw Pals or with Carrie Weiss at The Barker Bunch practices.
5. Members **must attend one of these August Skill-a-thon dates:**

6. Members **must complete interview judging with his/her 4-H Club Advisor.** A large portion of this score comes from the completeness of your project book.
7. The **dog project and record book is required** for all dog projects. The 201R Dog Resource Handbook is highly recommended for all dog projects, however, it is only required for the Dog Achievement program. This resource book is a one time purchase and can help you with completing your project book, skill-a-thon, and Showmanship questions.



## Junior Fair Exhibit Rules

1. The County 4-H dog judging will be Sun., Sept.13 starting at 2pm at the Fairgrounds. Yes, a week **BEFORE** the fair. Demonstration and awards will be Sun. Sept. 20, the first day of the fair.
2. Female dogs showing signs of heat will be permitted at county judging. However, the order in which dogs in heat will be shown will be at the discretion of the county dog advisors in order to avoid interference with other dog's performance.
3. Only domestic dogs may be taken to 4-H practices or shown. Wolf/ hybrids are not permitted.
4. Any dog exhibiting unsafe or threatening behavior *at any time before, during, or after exhibition*, will be immediately excused and will not be permitted to attend workouts, judging or the demonstration at the fair.
5. Pronged collars are not allowed at any practice or judging. A 6 foot leash is required for obedience, leather is preferred.
6. Participation at the Ohio State Fair Dog Show for Obedience, Showmanship, Rally, and Agility is open to all members. Entry deadlines start June 20. Ohio State Fair Dog Show is Aug. 3-6 with Agility on August 8. See leaders for exact dates. To participate at State Fair, dogs must have Rabies and DHLPP vaccinations current through the date of the state show you are participating in. Please check current State Fair rules if you plan to participate. **For State Fair, all vaccinations must be given by a licensed, accredited veterinarian.**
