

2024 Ashland County Breeding Sheep Project Requirements

Reminders for 2024

- **NEW: ALL animals must be entered and identified in member's 4Honline profile by June 1.**
- **Quality Assurance training by June 1 is mandatory for anyone taking a living, breathing animal project to the fair.**
- **For any breeding animal that is leased, lease form must be uploaded into member's 4Honline profile by June 1.**

Possession Date

All livestock projects must be in the care and possession of the 4-H/FFA member by June 1, 2023.

Required to Complete Project/Show at Fair

1. **Must be a member in good standing of a 4-H Club and be enrolled in #199 Breeding Sheep project or a FFA member with a Breeding Sheep project.** 4-H members can enroll and projects can be registered at <https://v2.4honline.com/>. Deadline to enroll in 4-H and be eligible to show at fair is April 15. Last day to add projects in 4Honline is June 1.
2. All animals must be entered and identified by their Scrapies tag number in the member's 4Honline profile by June 1. You must enter the entire 10 digit Scrapies tag number.
3. **All participants bringing a living, breathing animal to the fair must complete Quality Assurance training by June 1.** QA training will be offered by Ashland County in March & April. Other trainings may be accepted but contact the Extension office to find out for sure if they qualify. Proof of QA attendance must be provided to the Extension Office by June 1.
4. **Must complete Interview Judging.** Members will be evaluated using a rubric grade sheet and earn a superior, excellent, good or needs improvement grade as their performance dictates. Satisfactory completion of the project record book will be a large portion of this grade. Must bring current, up to date records for this year's project to judging.
5. **Must participate in the Ashland County Sheep Skill-a-thon.** Members who complete a Sheep skill-a-thon at The Ohio State Fair may have this counted as the skill-a-thon requirement. Participation in any other skill-a-thon is NOT accepted.
6. **Must submit an accurate online Junior Fair Entry through the Jr. Fair office by the August deadline.**
7. Breeding Sheep must be in full compliance of all Scrapies regulations and have an official Scrapies identification ear tag at the fair.
