

2024 Ashland County Dog Project Requirements

Reminders For 2024

- NEW: Members MUST attend at least 5 county 4-H dog practices to be eligible for the county judging.
- Quality Assurance training must be completed before June 1.
- Animals must be entered and identified in the member's 4Honline profile by MAY 1.
- State Fair: Must have paper copy of Certificate of Vaccination form filled out and signed by vet. State Fair entry deadline is MAY 21! State Fair Agility deadline is June 21.

Possession Date is MAY 1, 2024

Dog must be in the care and possession of the member by MAY 1, 2024.

No one other than the junior fair exhibitor is permitted to show the project dog at any type of dog show, including agility, rally, field trials, as well as fun shows, on or after MAY 1, 2024.

Required to Complete Project/Show at Fair

- Must be a 4-H member in good standing enrolled in one of the above projects or a FFA member taking a dog project. 4-H members can enroll and projects can be registered at https://v2.4honline.com/. Deadline to enroll in 4-H to be eligible to show at the Ashland or The Ohio State Fair is April 15.
- 2. Prior to participating in 4-H dog activities with a dog, a Permission to Participate form must be signed by the 4-H/FFA member and a parent/guardian each year. 4-H/FFA Members sign this electronically during 4Ho
- 3. **Must complete Quality Assurance training by June 1**. Ashland County will offer this training in several dates in March-April.
- 4. Dogs must be entered and identified in the member's 4Honline profile by MAY 1. FFA Members may also identify their dog in 4Honline. Vaccinations and county dog license information must also be entered here.
- **5.** Rabies and DHLPP vaccinations must be current through the Ashland Fair dog show date. Bordetella is recommended but not required. **Dogs must have a current County dog license.**
- 6. **Members MUST attend at least 5 county 4-H dog practices to be eligible for the county judging**. You may meet this requirement by attending the Ashland County 4-H dog practices held at the Fairgrounds on Monday evenings. Contact the Extension Office for schedule.
- 7. Must complete the Ashland County Dog Skill-a-thon requirement.
- 8. Must complete interview/project book judging. A large portion of this score comes from the completeness of your project book. You may use the project book for more than one year,





But you must complete a new record section each year.

- 9. The **dog project and record book is required** for all dog projects. There is an optional Dog Resource book available. It is a one-time purchase and is highly recommended for all dog projects as it can help you with completing your project book, skill-a-thon, and Showmanship questions.
- 10. Ashland County Fair Show Day: There will be an opportunity for dogs to take the Canine Good Citizen and/or Trick Dog test. A Dog Quiz Bowl and possible other events will also be done.

An explanation of Rally signs is also available there to print. These will help you practice at home.

Outstanding Dog Member Award

An outstanding dog exhibitor award will be presented to the dog member with the
most points. Points will be given earned throughout the year for attendance at dog
practices, Skill-a-thon score, State Fair and Ashland Fair classes entered, State Fair
and Ashland County Fair classes placed in, and community service.

General Dog Project Rules

Only domestic dogs may be taken to 4-H practices or shown. Wolf/ hybrids are not permitted.

- 1. Any dog exhibiting unsafe or threatening behavior at any time before, during, or after exhibition, will be immediately excused and will not be permitted to attend workouts, judging or the demonstration at the fair.
- 2. Pronged collars are not allowed at any practice or judging. A 6-foot leash is required for obedience, leather is preferred.
- 3. Participation at the Ohio State Fair Dog Show for Obedience, Showmanship, Rally, and Agility is open to all members.
- 4. Female dogs showing signs of heat should NOT come to practice but will be permitted at county judging at the owner's risk. Please notify the Extension Office at 419-281-8242 DAYS IN ADVANCE of the show if you anticipate you will be in this situation.
- 5. Please do not bring a sick dog to practice or a show. 4-H Volunteers reserve the right to send home any dog that appears sick.
