#### Horse Members

MANDATORY Horse Advisor & Parent meeting Sunday April 30th, 2 to 4 pm In Mozelle Hall at the Ashland County Fairgrounds. You MUST attend this meeting if you wish to be eligible for Ohio Sate Fair and Ashland County Fair this year. This meeting will go over new/existing rules, Safety requirements, etc. We will also be passing out and going over the parent/member form for this year. Again, you MUST attend this meeting, or you will NOT be able to go to state or the county fair this year. Any questions please contact Courtney, Horse Committee President.

Reminder: Horses need to be identified in 4Honline with pictures and lease agreement (if applicable) uploaded by MAY 1.

For 2023, all 4-H members registered for a horse project, will be required to complete the Equine Safety Training and Education Program (EquiSTEP) each year by May 1. EquiSTEP is an annual statewide requirement for all youth participating in Ohio 4-H Horse Program activities. The EquiSTEP curriculum focuses on helmet safety, equine safety & handling, equine health & nutrition, and sportsmanship and is designed to rotate topics every year. To complete EquiSTEP (due MAY 1):

- Enroll using their own unique email address. Participants should not use their school email addresses as the course enrollment invitation will be blocked by the school's email system.
- Participants must view all five videos which last approximately one hour in total. Once the videos are completed, participants will be able to access the 10-question quiz.
- Participants must complete the quiz associated with the training and achieve a minimum score of 7 (out of 10) in order to pass the training.
- Once the quiz is successfully completed, participants will need to complete the course survey to trigger a
  certificate of completion. The certificate will be emailed to the participant's email address as well as their
  county's 4-H email address IF YOU COMPLETE THE LAST STEP AND NAME YOUR COUNTY!
- IMPORTANT!! The participant must select their correct county to trigger the email to the correct email address and they must click on the submit button at the end of the survey to trigger the email.

# Ear Tags Now Available for Feeders & Market Animals

Ear tags are now available to tag your market animal and beef/dairy feeder.

Sheep, goat and feeders will have the 840 EID tags.

This year, swine tags will be the traditional fair tag (not 840 EID tags) due to an issue with our tag order. If your hog already has an 840 EID tag, do not remove it. You should record that 840 EID tag number in 4Honline. If you need an 840 EID tag for your hog to show at the State Fair, please contact your breeder, vet or the Extension Office. Hog tags should be placed in the RIGHT ear for ease of viewing during fair check in.

We ask that club advisors survey their members to know how many tags their club will need for this year.

- You will need to know how many swine tags and how many tags for other market species. (Goats, sheep and feeders will have the same type of tag).
- Tags may then be picked up for the club at the Extension Office or at the Senior Fair Office on the Fairgrounds. Advisors, you may delegate this task.
- Remember to log back into 4Honline and enter your animal under your profile. For those animals with the round 840 EID tags, You MUST ENTER THE ENTIRE EID TAG NUMBER INTO 4HONLINE in order for it to match the electronic scanner at fair check in.



#### Ohio Administrative Code Livestock Exhibition Rules

• PLEASE NOTE: counties may have ADDITIONAL rules in place and guidelines to meet, in order to be eligible to exhibit. For Example: The deadline for Quality Assurance completion in Ashland Co. is June 1- even though it is well before the 45 day deadline outlined in this document)

### 4-H Project Books

The State has increased the cost of 4-H project books. Most books will now cost \$8, with resource books and a few others costing more. While the Extension Office will keep a stock of livestock record books, we will no longer keep a stock of all the still project books due to expense and books outdating before being purchased.

We are asking that 4-H clubs take orders for any books their members may need and turn it in to the Extension Office so we can order those books needed for this year. We will place project book orders as we receive orders from clubs. Please allow 10-14 days from when you submit your order for the books to arrive at our office.

### Livestock Project Judging

You will be required to come to project Livestock judging before the fair with a completed record book! You may reuse a current project book and update the topics of interest, project activities, youth parent agreement etc.(dates will need to reflect current year) however you are going to be required to have CURRENT YEAR, completed records, for each livestock project!

For example: if you have a breeding goat and a market goat, those are separate projects and will require separate records. If you have two market goats, that is the same project and those records may be combined. In addition to a project book you may use the following tool--2023 Livestock Record--to meet the record keeping requirement. If you keep another form of electronic records covering these items, you may print and submit those at judging.

<u>2023 Livestock Record</u>: Use only if you are re-using a project book more than one year. This ensures you have current year records.

The record component will make up a significant portion of the members grade and the expectation is that each 4-H member will have completed records. It is recommended that an adult should review the record prior to judging.
