Ohio State Fair Commercial Cattle Show Opportunity

WHAT IS THE COMMERCIAL CATTLE SHOW?
The Commercial Cattle Show is an exhibition in which cattle are shown in a group of three. Cattle will be evaluated on a live and carcass basis. Cattle will be shown in three groups: Native Beef, Beef and Dairy. They must also be graded to live.

WHO CAN PARTICIPATE?
Any exhibitor who has membership with cattle may participate. There will be a junior and an open division. Youth under the age of 21 and registered youth groups are invited to participate in the junior division. All junior cattle will also be eligible to participate in the open division.

HOW DO I PARTICIPATE?
Entries will open on May 15. You can enter online at www.ohiostatefair.com (May 15 - June 21) or email Barb Preece at barpreece@ohiostatefair.com (June 21 10:00 pm - July 21). Specific entry and show information available at www.ohiostatefair.com. Fair Commercial Cattle do not need to be RFID tagged.

 - Cattle will arrive on Thursday July 27
- All cattle must be in place by 7:00 pm on Friday July 28. Cattle will weigh Saturday morning and show Saturday afternoon.

Livestock Skill-a-thon/Interview/Project Judging

You will be required to come to project Livestock judging before the fair with a completed record book! You may re-use a current project book and update the topics of interest, project activities, youth parent agreement etc. (dates will need to reflect current year) however you are going to be required to have CURRENT YEAR, completed records, for each livestock project!

For example:

- If you have two market goats, that is the same project and those records may be combined in the same book
- If you have a breeding goat and a market goat, those are separate projects and will require separate records. You may use a second project book OR you may use the following tool--2023 Livestock Record--in addition to your one book to meet the record keeping requirement for the second project. If you keep another form of electronic records covering these items, you may print and submit those at judging.

[2023 Livestock Record](#) : Use if you are re-using a project book more than one year or need an additional record keeping tool. This ensures you have current year records for each project.

The record component will make up a significant portion of the members grade and the expectation is that each 4-H member will have completed records. It is recommended that an adult should review the record prior to judging.

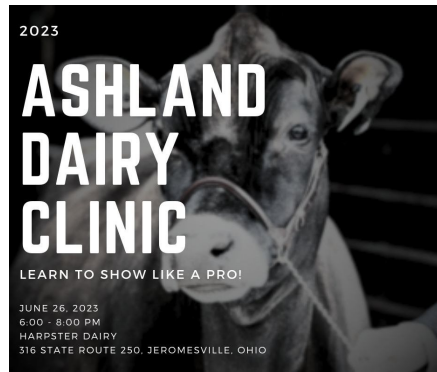

When reviewing the *OAC 901-19* (Ohio Administrative Code Livestock Exhibition Rules), here is a document to help clarify definitions and understand the expectations that must be met for all youth Junior Livestock Exhibitions in Ohio.

- **PLEASE NOTE:** counties may have ADDITIONAL rules in place and guidelines to meet, in order to be eligible to exhibit. For Example: *The deadline for Quality Assurance completion in Ashland Co. is June 1- even though it is well before the 45 day deadline outlined in this document*
- Please refer to Project Guidelines on our website and the Jr Fair Book for additional information on county specific rules.
