Reminders For 2024

- **All participants bringing a living, breathing animal to the fair must complete Quality Assurance training.**
- **ALL animals brought to fair must be identified under the member's profile in 4Honline, Breeding Beef by June 1.**

Possession Date is June 1, 2024

Breeding Beef project animal is to be in the care and possession of the member by June 1, 2024.

Required to complete Project/Show at Fair

1. **Must be a member in good standing of a 4-H Club and be enrolled in a #117B Breeding Beef project or an FFA member with a Beef Breeding project.** 4-H members can enroll and projects can be registered at <https://v2.4honline.com/> Deadline to enroll in 4-H and be eligible to show at the County Fair is April 15.
2. **All participants bringing a living, breathing animal to the fair must complete Quality Assurance Training by June 1.** QA training will be offered by Ashland County. Other trainings may be accepted but contact the Extension office to find out for sure if they qualify. Proof of QA attendance must be provided to the Extension Office by June 1.
3. **Must complete Interview Judging.** Members will be evaluated using a rubric grade sheet and earn a superior, excellent, good or needs improvement grade as their performance dictates. Satisfactory completion of the project record book will be a large part of this final grade. You must have current, up to date records for this year's project.
4. **Must participate in the Ashland County Beef Skill-a-thon.** Members who complete in an in person Beef skill-a-thon at the Ohio State Fair may have this counted as their skill-a-thon requirement. Participation in any other skill-a-thon is NOT accepted.
4. **Must submit an accurate Junior Fair Entry online through the Jr. Fair Office by the August deadline.**
